SRA Report:

There have been quite a few changes to regulations and rules mainly around safety, eg helmets. CEO Grant resigned in April and a new CEO Wesley Lloyd has been appointed. SRA have implemented a new back to racing program (for those who have been out of the sport for a period of time) and can be contacted regarding this. U13 Lites a speed restricted class has been introduced to help develop speed progression over the season. A new 60mph GPS is available. Safety/Scrutineering dates are on SRA website.

Greg Plummer

It was good to have 3 companies bid for insurance this season which helps with costs. Lower claims last season helped with insurance premiums. SRA have reduced boat and competitor fees this season. Greg advised that he and Tony are always available if members have any queries throughout the season.

Dave Bishop asked when the SRA AGM is – 10th October 2016 at Docklands.

Jenny Grech asked about new GPS – they are available for anyone needing to buy a new one, the one in rule book is no longer available for purchase. These are to be used whenever Racesafe is not used. - Doug Perry asked if the van was working out and what future plans for point score set up. It is on the agenda to look into a covered storage area for boats.
- Greg Plummer advised there is a CPR course being held on Sunday at SRA offices and are looking into running a final course in Bendigo in about 4 weeks. Paramedics last season did a great job.
